Mr. Ballering also informed the Committee that Thomas McGrath is no longer the agent for CVS. Alderman Sarrazin moved to defer this item until CVS names a new agent; Alderman Kaprelian-Becker seconded the motion. Motion carried on a voice vote.

Subject: Communication from Cherie Griffin requesting to appear before the Public Safety and Licensing Committee to discuss some absolutely wonderful projects that are going on with the Racine Police Department and collaboratively with the Courts, other law enforcement jurisdictions and the DA's office regarding practices to reduce domestic violence and to ensure the safety of the people of Racine.

Cherie Griffin, Executive Director with the Domestic Violence Task Force was present to inform the Committee on some accomplishments of the Task Force and area police departments. Ms Griffin indicated the Task Force is taking a pro-active approach in reducing the escalation of domestic abuse related homicides and re-occurances by working with law enforcement. With help from the Police Chief, grants have been obtained to purchase OSCAR alarms, GPS monitoring, video equipment for victim testimony at the crime scene and training for law enforcement and judicial staff. The approach is to hold offenders accountable from the onset so it doesn't escalate to a higher level of violence. A recent change that Ms. Griffin feels is beneficial is that there is no longer a third party surrender of fire arms and no third party service of restraining orders. Ms. Griffin encouraged the Committee to always think about how they could use their role in Public Safety to have a pro-active approach to reducing domestic violence deaths in the county and City of Racine.

Alderman Kaprelian-Becker moved to receive and file this communication, Alderman Morgenroth seconded the motion. Motion passed on a voice vote.

Mr. Stewart feels because of the changes, the younger crowd has moved on. There are no recent incidents of concern and Sgt. Rivers informed the Committee that Tropical Paradise is an establishment that has regular extra attention. Alderman Kaprelian-Becker moved to Receive and File this communication, Alderman Morgenroth seconded the motion. Motion passed on a voice vote.
