Call To Order

Chairman Wisneski informed committee members that Alderman Weidner would be sitting in as she will be at the next meeting as a member of the Public Safety and Licensing Committee.

Subject: (Direct referral) The Fire Chief requests the City waive formal bidding, allowing the City's Purchasing Agent to negotiate and sign an agreement with Pierce Fire Apparatus, committing to order a 2010 Fire Pumper. Initiating the process now avoids a significant price increase which begins January 1, 2010.

Sixty percent (60%) of the funding is available in account 989.300.5020. The balance to be allocated in the 2010 Bonded Capital Outlay Program, as submitted in 2008.

Recommendation of the Public Safety and Licensing Committee on 8-24-09: The City waive formal bidding, allowing the City's Purchasing Agent to negotiate and sign an agreement with Pierce Fire Apparatus, committing to order a 2010 Fire Pumper be approved.

Fiscal Note: Sixty percent (60%) of the funding is available in account 989-300-5020. The balance to be allocated in the 2010 Bonded Capital Outlay Program as submitted in 2008.

Chief Hansen appeared and informed committee members that a local supplier would take care of apparatus. He said it was designed for Wisconsin weather due to corrosion and he requested permission to waive formal bidding to avoid a significant price increase which begins January 1, 2010.

Tommy Daniels and Mary Hand appeared. Ms. Hand stated they wanted to run a place where their customers could come and feel safe while having a good time. She stated they would have security cameras and they would always have someone at the door checking ID's. Mr. Daniels stated he would be responsible for the day to day activities and he would be on the premise @ 80% of the time. They stated their hours of operation would be 7 days a week, 12:00noon - 2:00a.m. They would sell pre-packaged food items. Mr. Daniels states he rents the building.

The committee stated in his business plan it did not mention security cameras or the security that would be provided.

Alderman Shields spoke and asked for clarification as to whether or not the applicant needed to meet with the City Attorney's office to work out details with the cameras and security situation.

Alderman Kaplan made a motion to approve the application with conditions relating to security camera and security personnel. Motion dies for lack of second.

Alderman Mozol called Alderman Shields out of order for his behavior.

Alderman Weidner wanted it clarified that she was not able to vote on any action.

Alderman Kaplan made a motion that the item be deferred for two weeks and the applicant meet with the City Attorney to work out some details involving the camera system and security that will be used. Motion passed by the following voice vote:

Item #2 of the agreement dealing with the capacity, the Chairman would like the opinion of the Fire Department as to what the capacity limit allowed would be before agreeing to this. The other item was dealing with the restaurant maintaining an independent identity. The applicant would like it stated that the affects of the liquor license would only affect the bar area and not the restaurant. This would need to be clarified by the State of Wisconsin as to how this would be handled. Once the above have been clairified, City Attorney Weber will notify applicant and committee members to his findings before the final agreement is signed.

Owner stated he currently does not have a camera system in place, but he is willing to have one installed. Chairman Wisneski instructed the owner to get in contact with the Tavern League as they had information on different types of camera systems that could be installed.
