

# **Doobies Beer Joint**

01/03/2026

**Doobies Beer Joint** - Officers were dispatched in reference to large fights breaking out inside the bar and outside. Approximately six units were dispatched due to the call for service. While on scene, it appear the fights had stopped and people dispersed. While officers were on scene the staff was unable to work the security footage and no victims were located. Throughout the investigation it was learned two staff members were assaulted as they were trying to break up the fights. Broken glass was located inside the bar and also it appeared pepper spray was used during the fight.

After the incident, several videos surfaced via facebook in reference to the fight that took place. It appeared multiple parties were involved and the incident took place inside the bare.

A license premise report was completed and no violations observed at the time of the report.

11/02/2025

**Doobies Beer Joint** - Mount Pleasant officers were operating down Durand Ave. when they observed an active fight in the parking lot. As officers approach the parking lot. Problematic parties left. Due to Mount Pleasant generating a call, they did not complete a license premise report. License premise report will be assigned to tavern squad to complete.

10/17/2025

**Doobies Beer Joint** - Loud Music - Officers were dispatch in reference to loud music. Problem party was removed from the parking lot and a license premise report was completed with no violations observed.

10/12/2025

**Doobies Beer Joint** - Officers were dispatched in reference to parties loitering in front of the business.. While on scene, Officers made contact with a party who was allegedly assaulted and was a patron of the bar. The party became disorderly and was later cited for disorderly conduct. License premise check was completed and no other violations documented.

**Doobies Beer Joint** - Staff called in reference to being closed and over 200 people in the parking lot. Officers arrived on scene and assisted in clearing the crowd from the parking lot.

**Doobies Beer Joint** - Officers were dispatch in reference to noise violation. A vehicle was parked illegally with loud music. The party was advised and vehicle was parked. Officers conducted a license premise check and no violations observed.

**Doobies Beer Joint** - 3701 Durand Ave. - Officers were dispatched in reference to a civil trouble. Upon officers arrival, they observed over 100 people in the parking lot but not actively fighting. Observations documented, people leaving, arguing, and being verbally aggressive. Officers made an arrest. Contact was made with the bartender who advised they had several fights throughout the night and was the reason why they were closing. License premise report was completed.

**Doobies Beer Joint** - 3701 Durand Ave - Officers were dispatched in reference to a man with gun call and possible minors inside the bar. The complaint was unfounded. License premise report was conducted earlier in the night.

**Doobies Beer Joint** - 3701 Durand Ave - Officers were dispatch in reference to a fight. Upon officers arrival, they observed approximately 100 plus people (inside the bar, directly outside, and in the parking lot). Numerous parking violations were observed and several parking citations issued. License premise report was completed.

**Doobies Beer Joint** - 3701 Durand Ave - Officers were dispatched in reference to 20 people in the parking lot arguing. The complaint was unfounded and a license premise report was completed.
