Eric Ennocenti was present to discuss the application of Wisconsin CVS Pharmacy, for a Class "A" Retail Fermented Malt Beverage License for 1122 West Boulevard. CVS Pharmacy is located within 1000 feet of Port of Call Liquor, so there was a discussion regarding the geographic concentration restriction. Alderman Sarrazin told the committee she visited this CVS location. She stated CVS will only be selling beer, it will be in the back on an endcap by the pharmacy, and CVS advertises nationwide that they offer this service. Alderman Coe was present and offered his support for this license request. Alderman Kaprelian-Becker noted the number of phone calls received by both herself and Alderman McCarthy against this license. She also stated a group had come before the Common Council with concerns regarding infant mortality. Alderman Kaprelian-Becker stated the geographic restrictions was one way the Council offered to help with their concerns. Alderman Sarrazin made a motion to approve and override the geographic restriction due to placement of the product, and stabilization of existing business. Alderman Diehl seconded the motion. Motion passed on a voice vote.
