Subject: Request the appearance of Kenneth R. Meyer, Agent, of Kenny's on Main located at 1300 N. Main Street, to discuss the recent incidents (weekend of June 20 & 21, 2015) involving underaged persons in two accidents, resulting in two deaths.

Recommendation of the Public Safety and Licensing Committee 07/14/2015: That the matter of Kenny's on Main, located at 1300 N. Main Street, be referred to a due process hearing based on many incidents, underage drinking, noise and many people congregating outside issues to determine whether the license should be revoked or suspended.

Fiscal Note: Potential cost of Due Process hearing

Kenneth R. Meyer appeared before the committee and explained that in order to stop some of these incidents from occurring he implemented closing at midnight as of July 1st, 2015; then he has someone sit by the door at 10 pm to check identification - then they close at midnight. Kenny said they usually check ID's with scanners, but his scanner system broke. The committee questioned him about the Fourth of July event and other incidents. Sgt. Rivers pointed out that there were no video's inside the establishment. Kenny said the DVD burned out, so he bought a new one. Ald. DeHahn asked about more security. Ald. Kaplan said he's been asking Kenny for something to be done over the past three years. He mentioned a recent incident where he phoned 911 for a young male who was sitting on his back porch with a leg injury from an attack by 2 male patrons of Kenny's. He said there has been noise issues and issues with people standing outside. He said he also knows a former manager who quit since having a child. Atty. Weber added concerns of underaged persons in the bar - with one saying she was drinking in the bar. The motion to watch Kenny's to see if Kenny's changes solve the issues was made by Ald. Dehahn. motion failed; as the committee, along with Robert Mozol, agreed further action needed to be taken. Another motion, for a due process hearing, was made by Ald. DeHahn, Seconded by Ald. Land, and passed unanimously by a voice vote.
