TOBACCO COMPLIANCE CHECKS, JULY 14, 2007

Dear Ms. Johnson-Martin,

The following are the Racine establishments that were checked for tobacco compliance during the month of July by Investigator Jody Spiegelhoff.

Tobacco Compliance Checks

On July 14, 2007, Investigator Jody Spiegelhoff was assisted by two other Racine Police Investigators and 3 Explorer Scout Volunteers in conducting tobacco compliance checks in the City of Racine. I was able to check 56 establishments in the City. Out of the 56 inspections completed, only 2 sold tobacco to our underage volunteer. There were other establishments that were scheduled to be checked that day, however, they were either closed or out of business. They were not included in these results. They will be included in the WINS 3rd Quarter Report however. Also, the establishments listed who passed were notified by mail of the compliance check per the Wisconsin WINS agreement. The two establishments that were not in compliance were cited. The managers were served with the citations, due to the fact there was no listed agent.
