Please be informed that the Public Safety and Licensing Committee of the Common Council of the City of Racine will meet at 5:00 P.M., on Monday, October 30, 2023 in room 207B for a formal expression of concern issued pursuant to Section 6-27 of the Municipal Code, to address issue(s) related to the licensed premises located at 509 6th St. Racine, WI, 53403, including but not limited to the events below is a summary from the City of Racine Police Department:

Saturday, September 23, 2023 **23-039296**

509 Social Lounge- Civil Trouble- 509 Sixth St- A named complainant (victim) called about an altercation that took place inside the tavern. The complainant told officers that their keys were missing and needed assistance in finding them. Officers were able to locate the parties' keys and that resolved the issue for the night. Officers also did a tavern check and found all licenses were up to date.

509 Social Lounge- 509 Sixth St- civil- An officer observed a party in line at the tavern who was wanted after fleeing a traffic stop earlier in the night. Officers were able to make contact with the party and take them into custody without further incident. Call Received: 00:35

509 Social Lounge - 509 Sixth St- Assault- A named complainant (victim) contacted the police about an altercation the night before. The victim stated they were at the tavern when two known parties assaulted them inside the tavern. It should be noted that the officer taking the report did state that there were several unknown bystanders who observed the incident and no one called the police. The investigation is on-going at this time.

509 Social Lounge - 509 Sixth St- Noise Complaint- A refused complainant called about a noise complaint at the tavern. Upon officers arrival they observed several hundred people on the sidewalk, in the roadway, and across the street from the tavern. The officers also stated the patrons were extremely boisterous and refusing to listen to officers' commands to stay out of the roadway. Due to officers' safety and the large number of people in the area officers did not enter the tavern but stayed in the area to try and mitigate any further problems.
