All materials, equipment and labor are included in this Estimate unless specifically noted otherwise. Finished texture, color and trim/banding details TBD and may change cost depending on any trim detail changes out of typical. Ox and Bull Contracting will provide a 20 yard dumpster on site for duration of project. This estimate is based on site visits and drawing details provided by William Feldman dated,4/30/19. ALL PLASTER WORK to be performed when outside temps are 45 degrees or above. All soffit, fascia and roofing trim details to be provided by others. This estimate includes exterior water proofing of all surfaces, siding and EIFS materials and labor only. It is assumed all removal of existing coverings are to be done by others prior to start of project. Any demo needing to be performed by Ox and BullContracting can be addressed as a separate Additional Work Order, agreed to and signed off by both parties.

- Prepare existing exterior sheathing to receive TYVEK or similar vapor/moisture barrier wrap to all surfaces receiving new EIFS.
- Supply and Install all new wrap and tape all seams.
- EIFS system to be used is STO brand and will be installed per manufacturers specs and carry warranty as such.
- Supply and install new 1" foam per industry standard, bond, shave smooth to receive new base coat.
- Supply and Install new fiberglass mesh to ensure proper bonding of base coat.
- Hand trowel base coat of plaster and ensure full even coverage throughout. After base coat has cured, apply finish coat with paint color added and finish with a texture TBD.
- Sherwin Williams paint colors can be added to finish coat directly, eliminating the need to paint surface.
- Caulk all dissimilar material transitions with color matching caulk.
- Clean up site of all debris and material waste after completion. Site to be left broom clean.

- Frame infill at south elevation where windows were removed to have one uniform surface.
- Frame out front elevation at new "columns" for defined appearance and to stand out from new EIFS.
- Prepare existing masonry surfaces by waterproofing entire surface.
- Supply and Install furring strips and materials needed to ensure an even, smooth surface for new siding.
- Mechanically fasten all new rain screen material to furring strips and to create a blacked out under surface.
- Supply and Install new frieze board and metal drip edge below first row of siding.
- Corners to be mitered, pinned and glued with no corner boards. (as drawn)
- Supply and Install all new LP Smart Siding with a nickel gap spacing for the rain screen effect. Siding will not lap over.
- Supply and Install new back flashing for all butt joints and will be black in color. End cuts to be primed and fully painted to ensure proper installation.
- Supply and Install all Vulkem caulk to all ends and seams as needed to fully ensure proper sealing of product from elements.
- Color and texture (smooth or wood grain) TBD. Siding will be factory painted and special ordered with a 4-6 week lead time and carries the 25 year warranty on fade and failure. Details to be provided upon request.
- Clean up site of all debris and material waste after completion. Site to be left broom clean.

We propose to furnish and install the following 2" x 4-1/2" thermally broken storefront system in a dark bronze anodized finish and glazed with 1" clear low-e tempered insulated glass units as needed. Door is to be a medium style 3'6" x 7'-0" door with the following hardware: continuous geared hinge, ms lock with thumb turn, keyed cylinder, 1" diameter push pull handles, overhead surface mounted heavy duty closer, bottom threshold, bottom door sweep, necessary weather stripping, and glazed with 1" clear low-e insulated tempered unit. See approximate opening sizes listed below:

- 1 opening approximately 20'-6" x 9'-0" split into 5 lites with a single 3'-6" door and equal sidelites
- 1 opening approximately 5'-0" x 9'-0" single lite return panel
- 2 openings approximately 2'-0" x 3'-0" single punched openings
- 2 openings approximately 3'-2" x 4'-8" single punched openings
