DESCRIPTION OF PROJECT (attach additional pages if needed)

The project is to complete a reminiscence survey of an area if the City of Racine known as Manree Park; a residential neighborhood spanning approx 166 acres and encompassing a number of standard urban block subdivisions; two of the largest being Manree Park and Manree Park 2 (see attached maps). Platted between the late 1920's into the late 1940s, the Manree Park area contains homes whose dates of construction span from the 1850s to the 1960s. Home styles include italianate, four square, tudor, contemporary, cape cod, english cottage, bungalow, colonial revival and mid-century ranch. Some notable architect's whose works are represented in the area include local architect Anton Kratochvil as well as Edgar Tafel, and John Randel McDonald. Homes range in size from a modest ranch of 1,000 square feet to a stately foursquare of over 3,000 square feet. The homes hold the secrets of a 19th Century farmer, to a humble machinist, to a company executive, to an eccentric architect, to a toll house master of the Racine and Rock River Plank Road.

The goal is to accomplish a complete survey of the study area in a effort to heighten awarenes and appreciation of its architecture and history, and to establish the basis for national register nominations for properties and/or districts.



HOW DOES THE PROJECT MEET LOCAL HISTORIC PRESERVATION GOALS - Describe how the project meets local preservation goals. Describe in detail your community's adherence to its preservation plan, how this project relates to your community's preservation plan, and how this project addresses a specific historic preservation need in the community.

This project meets local preservation goals expressed in the document "A Comprehensive Plan for the City of Racine: 2035". This document emphasizes maintaining and promoting a diverse yet affordable housing stock. To those goals, housing should be provided that "... maintains and enhances the character of the City and its neighborhoods." The City should encourage the "... maintenance and rehabilitation, as appropriate, of the existing housing stock." Further, City housing policies should "encourage housing design that supports the conservation, enhancement and continued vitality of areas with special scenic, historic, cultural, or architectural value." Finally, cited as a housing financial assistance program, the Wisconsin Historic Home Owner's Tax Credit is listed as a potential resource available to people who rehabilitate historic, non-income producing, personal residences.(1)

Racine promotes or puts into practice the goals by enforcing standards for in-fill housing that respects the rhythm and street face of neighborhoods through minimum facade standards for private housing, and compatibility requirements for City constructed housing. The City offers low interest home improvement loans to income qualified homeowners who, in Racine, typically own homes well over 50 years in age.

This project, coupled with current efforts expressed above, relates well to the plan in that it will heighten awareness and appreciation by its inhabitants, and those City wide, of the Manree Park area's architectural and historic richness and character. This heightened awareness and appreciation should translate in many cases to a pause by a homeowner when they consider a remodeling or repair project. That pause can lead to the owner thinking "is this window, or door, or porch railing, or grout choice, the most historically appropriate solution to my needs?" Or, "can I get a tax credit for this rehabilitation work?"

This project addresses the need to inventory, understand and preserve buildings designed by local architect Anton Kratochvil and others, and those influenced or inspired by Frank Lloyd Wright such as Edgar Tafel and John Randel McDonald. This project can help better tell the story of the home for the areas original farmstead as well as that of the toll house master of the Racine and Rock River Plank Road.

Re: Survey of Historical and Architectural Sites

Dear Mr. Sadowski and Members of the Racine Landmarks Preservation Commission:

As we understand it, the City of Racine Landmarks Preservation Commission would like to submit an application for a Certified Local Government Subgrant for 2013 for an intensive survey of the Manree Park area. As part of the application process, you need to obtain two competitive quotes for the work. Legacy Architecture is more than happy to assist you in that regard.

Legacy Architecture, Inc. proposes to provide the following scope of services according to guidelines described in the Wisconsin Historical Society Division of Historic Preservation-Public History's *Architecture-History Survey Manual*:

- 1. Conduct one initial public education meeting with the City of Racine to introduce the project and the principal investigators to the community. (2 hours @ \$90/hour + 2 hours @ \$45/hour = \$270)
- 2. Perform a reconnaissance survey of approximately 654 buildings, excluding properties already listed in the National Register of Historic Places, in order to document properties of architectural or historical interest and potential significance. Previously surveyed properties that have been altered, restored, or demolished will be updated. Provide survey maps indicating all surveyed properties by lot lines and referenced by the AHI record number. Survey maps will be provided to the City and the Wisconsin Historical Society. (12 hours @ \$90/hour + 110 hours @ \$45/hour + 2000 miles @ \$0.56/mile + miscellaneous expenses = \$7,200)
- 3. Perform an intensive survey including site specific research and preparation of the survey report. Historic research will be conducted on all properties potentially eligible for the National Register of Historic Places or within a potential National Register historic district. All findings of potentially eligible individual properties and historic districts will be approved by the Wisconsin Historical Society prior to completion of the intensive survey report. All survey data will be entered into the Wisconsin Historic Preservation Database (WHPD). The intensive survey report will be prepared including an introduction and chapters on survey methodology; historical overview; all themes represented in the history of the survey area; architecture; designers, engineers, and builders; notable people; survey results; and recommendations. A typed draft of the report will be submitted to the City and the Wisconsin Historical Society for review. The City will be given 3 double-sided and bound copies of the final report (1 of which shall be deposited in a local library) and an electronic version in PDF format. At least 7 double-sided and spiral bound copies of the final report and an electronic version in PDF format will be submitted to the Wisconsin Historical Society by the project completion date. (40 hours at \$90/hour + 150 hours at \$45/hour + 1500 miles @ \$0.56/mile + miscellaneous expenses = \$11,600)
- 4. Conduct one final public education meeting with the City and the Wisconsin Historical Society to make a formal presentation of survey findings by the principal investigators and explain the National Register of Historic Places program. (6 hours at \$90/hour + 8 hours at \$45/hour + 178 miles @ \$0.56/mile + miscellaneous expenses = \$1,000)

We assume that the following:

- 1. The Initial public education meeting shall be held concurrently with the commencement of the reconnaissance survey.
- 2. The City will schedule, provide a meeting room for, and prepare public notices for the public education meetings.
- 3. The City will provide DWG or DXF format files or aerial mapping of the survey areas, including streets, property lines, and building footprints so we may accurately provide mapping.

Legacy Architecture, Inc. intends to provide the abovementioned scope of work for a total lump sum cost of \$20,000.00. Legacy Architecture, Inc. will bill the City of Columbus monthly based on the actual hours and expenses accrued until the above scope of work is complete.
