Community Health Programs – There was some type of outbreak today. Twenty one of 39 6th grade kids and two teachers at one school have gotten sick. A few kids in other grades are also sick. The state is starting an outbreak investigation. There has been a shigella outbreak in Kenosha at a daycare.

The Health Department has no flu vaccine for ages 3-18 but does have Flumist for kids age 5-18 who have no immune diseases. They just received more vaccine for 6

months – 3 years. Flu vaccines are now being given to non-high risk clients. The department is worried that if they don't receive more vaccine soon their clients may go elsewhere and they would have unused vaccine. They get their vaccine through MCAP to get a better rate. Private providers got a lot of vaccine while public health departments got very little. WALHDAB is pushing to solve this problem.

Clinic – The clinic has a new employee, Monica Guzman, a bilingual WIC clerk. They're still looking for a nurse practitioner for the STD Clinic. Judy Bagley is filling in for now on Fridays. They are also looking at alternatives.

Laboratory – The lab found 2 direct sanitary connections from the storm sewers to lake contamination. Lead draws haven't been billed lately because of a referring physician glitch with Medicaid. The problem is being worked on.
