Scott Arendt, Owner of Bar 525 was present to discuss the concerns that the Committee has regarding incidents at his establishment. Mr. Arendt informed the Committee that he no longer has DJ's which results in a more diverse crowd, he chooses to close around 1:30-2 a.m which is earlier than required by law, and that his bouncers have been directed to frisk search and check ID's at the door to deter alcohol or weapons being brought into the establishment. Mr. Arendt stated it is difficult for his staff to manage or control what happens out on the street after they have left his establishment. There was discussion regarding the shooting outside of his establishment and Mr. Arendt stated they spoke with officers regarding the incident, but his cameras only record 7 days of film and the night in question was no longer available when he was questioned. Arendt agreed to meet with Lt. Macemon from the Racine Police Department to discuss ideas for managing the crowds and alleviating some of the issues that occur at Bar 525. Mr. Arendt was reminded he should update the Change of Agent if Jim Dispasquale is no longer acting as Agent. Alderman Kaprelian-Becker moved, seconded by Alderman Sarrazin to receive and file this item. Motion carried on a voice vote.

He informed the Committee that they are doing a great job in ensuring bar owners and agents are compliant with the law and that when agents, tavern owners, Operators and license holders are requested to appear before the committee, those people are very concerned as this committee can have an effect on their livelihood.
