Ald. McCarthy advised that the Park Pride Advisory Committee was formed by the Mayor to improve upon and increase participation at our parks. Five sub groups have been formed to better focus their attention. For example, Ald. McCarthy's sub group will be focusing on communication and surveying the public. They are working with UW Parkside on developing a survey of the public's desires for parks and recreation.

Kristen Kaprelian read the goals of the five sub groups:

- 1) Improve communication among Parks and Recreation and Cultural Services Department and its stakeholders
- 2) Maximize creative, innovative and interesting use of natural resources, facilities, infrastructure and programs
- 3) Develop and deepen partnerships with public agencies, service clubs, businesses, nonprofits and educational institutions.
- 4) Diversify funding for sustainability
- 5) Engage community members to take ownership in parks and programs.

Ald. Wisneski indicated he thought it was encouraging that there were members of the community who were interested in improving our parks, and stated the importance of keeping staff informed of Park Pride's activities and plans. It was advised Tom Molbeck and/or Donnie Snow have been in attendance at the meetings.
