Official Notice #3, TWO (2) HEAVY DUTY, LOW ENTRY, DUAL STEER CAB TRUCK CHASSIS, WITH 25 CUBIC YARD HIGH COMPACTION REAR LOADING REFUSE PACKER, was opened in the office of the Purchasing Agent at 10:00 A.M. on February 25, 2014. The following is a tabulation of the bids received:

The City Fleet Manager and the Purchasing Agent have reviewed these bids. The lowest bidder was RNOW for the Peterbuilt 320 chassis with the Loadmaster Excel packer, however after review of the specifications, it was determined that Peterbuilt chassis did not fully meet the City's specifications. We have determined that the bid offering the Mack LEU with the Leach 2RIII from the Kriete Group is the low responsive responsible bid.

Recommendation: It is recommended that this bid be awarded to Kriete at their bid price of \$392,980 for two (2) Mack LEU 613 with Leach 2RIII packer they being the low responsive, responsible bidder. It is further recommended that we accept their offer of \$15,800.00 for our trade-ins. The net outlay for this purchase will be \$377,180.00.
