Update on Humble Community Center Guest: Community Center Supervisor, Jason Mars

Community Center Supervisor, Jason Mars highlighted some of the changes made at the Humble Community Center since the beginning of 2012. Despite having lower staff levels, the center has not discontinued any programs. The center now closes at 7:00 p.m., which is different from past years.

Currently the Optimist Youth Softball is underway. Mars stated it was tough getting coaches this year. The playground program will begin next week. There are over 60 children signed up to attend Humble Park for this program. Main Gallery planning has been underway. There will be 32-33 participating in 3 different Main Gallery programs this year. 75 kids had applied for the program.

Rosholt inquired if the level of activity is less in the winter. Mars stated the attendance is pretty steady throughout the year. A lot of children come to the community center right after school and there are also some large programs in the fall/winter such as Optimist Basketball.

Chair McCarthy asked how Mars was affected by running two community centers. Mars stated it has been challenging. He's had to rely on part time staff. Having part time staff is crucial especially with additional programming such as pickleball and softball for seniors. Mars stated there has been great team work, and Molbeck has been very helpful.

Hemmig asked Mars what his top five needs were. Mars listed three. 1) More part-time staff. Staffing is huge for mentoring & coverage of the center. 2) Replacement of mechanical type items. 3) Funding for activity equipment and supplies.

Molbeck commented that Mars is doing a really good job. Continued support from the board is very important.

Molbeck stated there is already an existing contract for Humble Park with Optimist and would like Nelson Concession's to start out with Island Park only. Bonnie Nelson stated she was okay with this.
