Subject: Calls to Licensed Premises 02-17-10 - 03-03-10

02-17-10 20:50 hrs Blind Alligator – 1655 Taylor Ave. – Complainant reporting 2 women inside the tavern selling crack cocaine. The caller named one of them. Police checked the premise and the women were not there. Unfounded call. 10-008586

02-17-10 21:29 hrs. Blind Alligator – 1655 Taylor Ave. – Officers initiated a traffic stop of a suspicious vehicle outside the tavern. Not related to the operation of the premise. 10-008590

02-18-10 23:25 hrs. Blues and R&B (former Captain’s Quarters) – 1220 Mound Ave. Officers outside the tavern on an unrelated matter heard a 30 y.o. woman screaming outside the tavern. The woman told officers she had just been assaulted inside the tavern by two women and the license premise holder.

Officers investigated the complaint and spoke with the license premise holder who cooperated with the officers and further showed them video from the premise surveillance system. The video showed the woman, who claimed to have been assaulted, enter the tavern and begin to argue with a female patron at the bar. The argument quickly turned into a fist fight at which time the alleged “victim” grabbed a liquor bottle from behind the bar and came after the female patron. The license premise holder took the bottle away from the woman while other patrons attempted to separate the two women. The alleged “victim” then leaves the tavern and begins to scream for police officers who were outside.

Police arrested the 30 y.o. woman and charged her with disorderly conduct. 10-008814

02-19-10 14:11 Blues and R&B (former Captain’s Quarter) – 1220 Mound Ave. Police called to hospital emergency care for female 38 y.o. claiming she was assaulted inside the tavern the previous night (see above). The woman left the hospital prior to the arrival of the police and did not file a report. 10-008906

Calls to Licensed Premises 02-17-10 to 3-03-10

02-19-10 23:26 hrs. Park Six – 500 Sixth St. – Metro Security waived down police supervisor and reported an unwanted man who refused to leave the premise. Officers asked the man to leave the tavern. The man told officers he wanted the money he paid for the cover charge refunded to him. Officers attempted to escort the man out the tavern at which time he began to resist the officers and push away from them. Police arrested the 22 y.o. man. He was charged with disorderly conduct and resisting arrest. 10-009043

02-20-10 00:32 hrs. Ray Town Road House – 522 Sixth St. – Police supervisor waived down by Metro Security informing him of a man with open intoxicants outside the tavern. Supervisor observed a 34 y.o. man standing in front of the premise with a drinking glass in his hand. As the supervisor approached the man, security from the tavern came outside, took the drinking glass away from the man and returned it to the tavern. Supervisor spoke with the man warning him not to leave the premise with a glass. The man appeared intoxicated and told the supervisor security for the tavern warned him not to go outside with a drink, but he did so anyway. The supervisor further spoke with male 50 y.o. who was working security at the door of the premise and warned him to pay closer attention to patrons trying to leave the premise with barware. 10-009048

02-21-10 00:36 hrs. Ginger Lounge – 345 Main St. – Off-duty officer working at the premise arrested males 22 and 23 y.o. for fighting outside the premise. The men were charged with disorderly conduct and resisting arrest. 10-009202

Teezers – 1936 Lathrop Ave. – Police arrested male 40 y.o. for criminal damage to property and disorderly conduct after the man was observed damaging a car in the tavern parking lot. The man entered the tavern and was soon told to leave because of his intoxicated condition. The man became angry, went outside and began to vandalize a car belonging to a tavern customer. Police found the man lying down in the parking lot and discovered he had broken his ankle while kicking the patron's car. 10-009719

02-26-10 9:59 hrs. Vintage Rock Café – 3701 Durand Ave. – Woman called police to her residence claiming she was drugged while at the tavern last night. The woman was advised to seek medical attention. She was provided with a complaint number in the event there was medical evidence supporting this. She has not re-contacted the police. 10-010108

02-27-10 1:51 hrs. Park Six – 500 Sixth St. – Officers stood by for crime prevention while the tavern closed. Six officers and a police supervisor were on-scene for 6 minutes. No incidents occurred. 10-010247

02-07-10 1:55 hrs. The Place On Sixth – 509 Sixth St. – Police supervisor conducting crime prevention activities at the premise across the street observed a large crowd coming out of the Place On Sixth. The crowd was blocking traffic on Sixth Street causing traffic leaving the other premises to back up. During this time two women began to argue in the street and threatened to fight. The crowd remained anticipating there would be a fight. Officers were able to separate the women and continue to move the crowd along. The women moved down the block and resumed their argument. Officers detained the women and issued each of them citations for disorderly conduct. Six officers and a police supervisor were on-scene for 32 minutes. 10-010249

02-27-10 22:34 hrs. Park Six – 500 Sixth St. – Metro Security officers requested police assistance for an unwanted man who wouldn't leave the premise. The man had started a fight inside the tavern and further struggled with security officers. Police issued the 23 y.o. Milwaukee man a citation for disorderly conduct. Officers conferred with an off-duty officer working at the premise and all agreed the music had not been loud throughout the evening. Repeated calls were received prior to closing, and at no time did the officers find the music to be excessively loud. 10-010402

02-28-10 2:00 hrs. Park Six – 500 Sixth St. – Officers called to a residence where victim male 22 y.o. reported he was punched in the nose by a man he knew while inside the tavern last night at about 1:30 hrs. Victim had gone to a local hospital after this occurred, but did not wait for officers to take his report.

Victim is employed by the Park Six to pick up and wash drinking glasses. A male patron had asked the victim for a drink. The victim told the patron he was not allowed to make drinks because he was a back bar helper. The patron male told the victim he did not like his attitude.

As the victim began to pick up drink glasses near the dance floor, he was punched in the face by the same male patron who had asked him for a drink. The victim tried to defend himself but he was taken to the floor by "his boss" and told not to get up until the suspect left the tavern. The victim was then ordered to leave the tavern via a rear door. The victim sustained a contusion and swelling to his nose. On 3-1-10 a letter was sent to the victim requesting him to provide additional details regarding his complaint. 10-010418

02-28-10 2:04 hrs. Park Six – 500 Sixth St. – Officers called for an assault taking place outside the tavern involving two female patrons. Victim female 26 y.o. reported being confronted inside the tavern by suspect female 27 y.o.. An argument ensued and carried out of the tavern into the parking lot. There, the suspect struck the victim in the face. Victim did not have visible injuries. While the victim was giving her statement to officers, the suspect approached the victim and began screaming at her. Officers took the suspect into custody. The suspect was placed inside a police transport van where she continued to yell, scream obscenities and kick the sides of the van. The suspect was conveyed to the county jail and charge with disorderly conduct. 10-010419

02-28-10 2:12 hrs. Evelyn's Club Main – 331 Main St. – Police called call for a man down inside the tavern. As police tried to determine the cause for the victim's emergency and clear a pathway in the crowded tavern for arriving Fire- EMS, 2 tavern patrons male 30 and female 29 refused to comply with officers orders to clear away from the scene. These persons had to be physically pushed back in order for the officers and EMS to attend to the victim. After the victim was conveyed to the hospital by EMS, the two patrons were issued citations for obstructing officers. Afterwards, the officers learned the victim was intoxicated.
