Attorney Weber told the committee he wasn't able to find any prohibition against it. Sgt. Rivers noted there have also been a lot of noise violations due to large crowds at closing, and a call of shots fired on 07/26/2014. Joey LeGath said he thought that an establishment serving food after hours was required to lock up liquor or move the liquor so it's not visibly seen. Sgt. Rivers said Curmudgeon's Pub has had a number of calls from unhappy property owners in the area. There are two off duty officers there to address issues, and a majority of them have been unfounded. He said it's a busy bar, and the parking lot is small, so patrons are parking in the area. Alderman Sarrazin moved to Receive and File the report. Alderman Diehl seconded the motion. Motion carried on a voice vote.
