Dear Ms. Evans,

Please be informed that the Public Safety and Licensing Committee of the Common Council of the City of Racine will meet at 5:00 P.M., on Wednesday, March 12, 2025 in room 207, City Hall, pursuant to a formal expression of concern issued against you as it relates to the licensed premises located at 1111 Washington Ave, Racine, WI, 53403, under section 6-27 of the City of Racine Code of Ordinances. Specifically, the relevant issues include but are not limited to the following incidents:

01/30/2025 – The City Attorney's Office received a complaint that the licensee advertised an event at the licensed premises on 1/30/25 involving adult entertainment, flyer attached. RPD Follow up requested.

01/31/2025 – RPD incident # 25-004187 - Fight , called in by uncooperative unknown caller - Caller stated there was a large fight at 1111 Washington Ave. Prior to officers' arrival, the fight had dispersed with a few problem parties in the BP parking lot. Those parties were addressed by officers and later left the scene.

02/09/2025 – RPD incident # 25-005473 - Extra Attention - Officer initiated a call for service to provide extra attention to the establishment. Officers observed several parking violations, and patrons parking in Tino's parking lot without permission. Several parking citations were issued.

02/23/25 – RPD incident #25-007427 – Officer initiated a call for service to provide extra attention to this establishment. Tino's parking lot had numerous cars parked in parking lot. Key holder was unsure if owner gave the OK for cars to be parked in lot. No citations written at this time. 111hrs. At 127hrs, while giving extra attention, officers on scene observed a possible fight taking place. Fight and crowd were eventually dispersed.

02/24/2025 – RPD incident #25-007624 - Assault report, called in by victim. Party called for assistance from the hospital stating she was assaulted by another party while at 627 Select on 02/23/2025. Officers took her statement, and took photos of her injuries. Officers were able to make contact with the other party who stated the alleged victim is the one who started the fight and threw the first punch. Due to both parties not wanting to press charges and only wanted it documented, a report of this incident was generated.

Please be informed that the **AGENT'S APPEARANCE IN MANDATORY** and failure to appear may result in a suspension or revocation of your license.

Sec. 6-27. - Actions by the committee.

(a) Formal expression of concern. (1) The public safety and licensing committee may require the appearance of any licensee before the committee at any time to address issues related to the licensed premises through a written formal expression of concern, sent via first class mail to the licensee. (2) If the licensee fails to appear for the formal expression of concern, the committee may refer the matter to the city attorney's office for consideration of further disciplinary action. (3) If the licensee appears for the formal expression of concern, no discussion of the alleged facts may be permitted unless the licensee requests such discussion and only after the licensee has been advised that any statements made by him or her and/or his or her representatives regarding the alleged underlying facts may be considered by the due process board in any subsequent suspension/revocation hearing which may result from the alleged violations which are the subject of the formal expression of concern. (b) Referral for disciplinary proceedings. (1) Any licensee who has been issued two formal expressions of concern within a six month period, or three or more formal expressions of concern within a one year period, shall be referred to the city attorney's office for consideration of further disciplinary proceedings as contemplated under section 6-26 of this Code. For purposes of this section, the date the committee votes to issue a formal expression of concern shall be the date used to calculate any time period prescribed. (2) Nothing in this section shall be construed to conflict with, abridge or modify, the rights or procedures established for revocation or suspension of licenses in Wis. Stats. § 125.12 provided there is cause for disciplinary proceedings under the relevant ordinances or statutes.
