Dear Alder Jones:

On January 1, 2024, the municipal solid waste disposal contract with GFL will expire. DPW estimates that operations will continue in the existing transition plan until July 1, 2024 at which time operations will be switched to the completed transfer station on a full time basis. Thus the contract with GFL – Emerald Park needs to be extended until the transfer station is fully operational. GFL has proposed the following pricing:

Waste Type	GFL - Original Bid	Prop. Tipping Fees (2024)
Municipal Solid Waste	\$40.00/ton	\$41.00/ton
Construction & Demolition	\$40.00/ton	\$41.00/ton
Bulk Items	\$45.00/ton	\$46.15/ton

The proposed pricing represents a 2.5% increase for both municipal solid waste and construction and demolition materials, and a 2.6% increase for bulk items. The total cost for an additional six months in the transition plan is approximately \$625,000.

Staff recommends that the Public Works and Services Committee approve the contract extension with GFL – Emerald Park at their proposed rates outlined above.
