### Approval of Minutes for the November 11, 2014 Meeting.

The minutes of the November 11, 2014 meeting were approved as printed. Passed unanimously.

**Subject:** (Direct Referral) Communication from the Commissioner of Public Works submitting bid results on Contract 36-14 (K4-036), City Hall Annex - Replace Fire Alarm.

Recommendation of the Public Works and Services Committee on November 25, 2014: That Contract 36-14(K4-036), City Hall Annex - Replace Fire Alarm, be awarded to WIL-Surge Electric, Inc., at their bid price of \$104,811, they being the lowest responsible bidder.

**Fiscal Note:** Funding to defray the cost of this public works project be appropriated from Account 994.200.5020, Annex - Upgrade Fire Alarm.

Tom Eeg recommended this contract be awarded for the base bid amount.

**Fiscal Note:** Rental rates will increase in 2015 due to the 2014 Consumer Price Index increasing by 2.1%. These leases will generate a total annual revenue of approximately \$116,956.40.
