This communication is a cost estimate and scope of services to be provided by Dettmann & Associates, LLC for the purpose of developing a Relocation Plan and Relocation Assistance for the above referenced Redevelopment Authority project.

Dettmann & Associates, LLC (DALLC) will oversee and provide services to develop a Comm 202.29 Small Projects Relocation Plan in accordance to the Uniform Relocation Assistance and Real Property Acquisition Polices Act of 1970 as amended, 49 CFR Part 24, ss.32.185 to 32.27, Wis. Stats., Department of Commerce Administrative Code 202 (COO 202) and the Wisconsin Department of Transportation. Said Plan will contain one (1) business and one (1) residential unit.

These lump sum fees are based on an hourly rate of \$80.00/hour. Above amounts include all expenses incurred by DALLC to perform said services. Expenses include clerical costs, printing costs, mileage and any other incidental expense.

The fee of \$2,250.00 will be paid when the Plan is approved by the Wisconsin Department of Commerce.

The fee of \$4,800.00 will be paid in two (2) installments of \$2400.00 each. The first installment will be due four (4) weeks after the delivery of the relocation eligibility letter. The final installment will be due when displacees are relocated to new sites.

These fees do not include litigation preparation or court appearance fees. In the event that those services are required, an additional cost of \$150.00/hour will be billed.
