DEPARTMENT: Community Health Programs (CHP)

REPORT FOR THE MONTH OF: January 2007

Highlights:

- Mr. Jeff Schmidt, Epidemiologist, presented information on Sexually Transmitted Disease to one Special Education class at Park High School on January 10.
- The WIC program has had the caseload increased to 1463 per month. Just a year ago WIC was having difficulty reaching the monthly caseload of 1377 but with hard work from staff was able to reach and exceed that. The caseload was increased near the end of 2006 to 1408 and then again effective January 1, 2007 to 1463. In January, the program served 1557, well above the new caseload. Caseload determines the funding so we will have an increase in funding for 2007.
- Public health nurses, Pat Anderson, Marcia Rottino and Brenda Wilkinson, visited Head Start on January 16 and applied topical fluoride varnish to teeth of 29 children.
- Ms. Sue Napier and Ms. Marcia Rottino prepared an informational tool on infant mortality for the display case on first floor of city hall.

Outcomes:

- Outcome reports were completed for the Brighter Futures and Teen Parenting Support Programs. 95% of teen parents in the program remained pregnancy free during their service period and 87% graduated from High School or advanced in school.
- Public Health Nurses exceeded the goal of applying fluoride varnish to the teeth of 55 children ages 6 months to 5 years by serving 320 children in that age group for fluoride varnish. An additional 122 clients older than 5 also had fluoride varnish applied.
