2014 CITY OF RACINE BROWNFIELDS CONTRACT (FINAL)

City of Racine 2013 Contract Activities Highlight

Assistant Director Sadowski explained the continuation of services for renewing the brownfields contract with Racine County Economic Development Corporation. He introduced members from the Racine County Economic Development Corporation (RCEDC).

Gordy Kacala, Executive Director of RCEDC spoke regarding the brownfields contract and the milestones that have occurred over the past few years. He stated that activities under brownfields have increased dramatically from three contracts worth \$1.5 million in 2012 to 14 contracts worth \$3.2 million in 2014, and highlighted activities specifically under the Uptown and Root River initiatives.

Karen Frost, RCEDC, went through the major accomplishments under the grants and the sites, such as Racine Steel Castings, that will be ready this spring. She discussed the Harborside site and the funds that were secured so that remediation of the site can begin. She explained the new funding sources and how we have gone from three active grants, closed one and increased that number.

Mr. Sadowski stated there is a \$10,000.00 increase in the contract amount from last year due to the increase in the number of grants the City has and is anticipated to receive.

A motion was made by Commissioner Garner, seconded by Commissioner Nicholson, to adopt RDA Resolution 14-04, recommending approval of the item and referring the item to the Finance and Personnel Committee. The motion PASSED by a Voice Vote.

Mr. Kacala introduced the item and described the Launch Box program. He introduced Brian Albrecht, president of Gateway Technical College who summarized current programs at GTC as they relate to the Launch Box Program.

Kristin Niemiec, RCEDC, went over activities within the last year accomplished by the program. She described the brochures that were created, the space that was acquired, and the competition that was held. She went through the proposed contract and stated that the program was shifting from being a referral center to being a growth wheel. She stated the hope is to increase the number assisted to 115. There is no change in the dollar amount of the contract from last year.

Mr. Sadowski read the Resolution for the item.

A motion was made by Commissioner Nicholson, seconded by Commissioner Garner, to adopt RDA Resolution 14-05, recommending approval of the item and referring to the item to the Finance and Personnel Committee. The motion PASSED by a Voice Vote.
