The following report reflects calls for service regarding Licensed Premises which have been submitted to Investigator Jody Spiegelhoff.

Shockers 1632 Douglas Ave. 06-057250 08-31-06 2:13 AM

At 2:13 AM officers observed numerous people inside of Shockers Bar. When officers attempted to make entry, all doors were locked from the inside. The occupants were unwilling to open the doors for police, therefore four other officers, including a Sergeant, were called to Shockers to assist. After officers arrived, contact was made with the owner **AMER ASSAD**. **ASSAD** advised officers that he "lost track of time."

Officers wrote a total of **28 tickets** to numerous patrons, the bartender, and owner of Shockers. **ASSAD** was issued two citations, and his bartender, **TONY PARHAM**, was issued one citation. There were also two arrests made from Shockers during the same incident, due to outstanding warrants for two individuals.

While writing patrons citations inside Shockers, an officer observed a semi auto handgun (loaded) between a pillar and the bar, which was very near where **TONY PARHAM** was sitting with 5 other male patrons. According to an officer's report, he's known **PARHAM** to carry guns in the past. The gun was confiscated by the officer and inventoried as evidence.
