Alderman Helding:

Attached is what we have from the PH. We provide the PW&SC with any and all documentation as long as it is received no later than 10 days after the PH. We offer sidewalk for proposed improvement in an effort to comply with complete streets philosophy and state guidance. It is up to the PW&SC and CC to approve or delete projects and I cannot speak to the reasons why they vote the way they do.

I am sure the final resolution could be amended to delete the sidewalk but that is a political decision you need to have support from your colleagues on. Earlier this year, Ald. Diehl wiped out an entire street after it was approved, let for bid, and awarded to a contractor so I'm sure this can be done.

If there's no support to do that, I told your constituent we can work to place the sidewalk in a reasonable location. However, the landscaping is clearly in the public right-of-way as an encroachment without permission by revocable permit. This doesn't mean there's a guarantee from this office we'll be able to save his landscaping. As always, feel free to call and discuss.
