Name of Event: Pro Am Beach Soccer Regional Qualifier

Description of Event: This is a 3-day beach soccer tournament held for competing teams in the Midwest Region. There are between 80-100 teams all competing for a spot in the US Beach Soccer National Championship (which is also being held at North Beach in August, pending approval.) The matches are held on 12-14 courts laid out on North Beach by the event organizer. This tournament includes youth, adult men and adult womens teams.

Park Location: North Beach & Volleyball Courts. Please note that all the Volleyball Court posts MUST be removed to allow for space for up to 14 fields.

Date/Time: Friday through Sunday, July 20-22, 2018 from 8am-7pm. Obviously times will depend on number of teams and speed of play.

Schedule:

Set up of goals and fields will take place Thursday, July 19. Posts for the volleyball nets must be removed before that day or during the morning on Thursday. Once fields are set, they are open for practice on Thursday as teams deem necessary. Matches run nearly continuously from 8am-7pm Friday, Saturday and Sunday. Timing is TBD until schedule is set but that would be the longest timeframe. The final Championship Matches will occur Sunday late morning, early afternoon based on current estimates. Teardown begins immediately after the last match on Sunday and continues until complete on Sunday.
