**Recommendation of the Community Development Committee on 7-16-15:** That the request by United Way of Racine County be

approved; and

That the Mayor, City Clerk, and Director of City Development be authorized to execute an amended written agreement with the United Way of Racine County to reduce the contract with Racine Vocational Ministries by \$1,500.00, and increase the contract with the Center for Veterans Issues by \$1,500.00 and extend its term to September 30, 2015.

1801 Grand Application Workbook - Ownership

Jeff Vitton, Community Development Program Specialist gave a presentation regarding the Housing Department's request for HOME funds to build a single-family house on a city-owned corner lot. The property was acquired by the city in cooperation with Racine County through tax foreclosure at a nominal cost. An unsafe blighted structure on the property was then demolished through a State of Wisconsin grant program. The now vacant property now requires ongoing snow removal and lawn maintenance at the city's expense.

City Development staff recommended funding at only \$239,500.00 because the contingency requested should not be needed given the recent construction of a nearly identical house by the City of Racine's Housing Technician Mike Lechner at a lower cost. Mike Lechner was present to answer additional questions. Frasher questioned the price of the house; Vitton explained it was within standards for cost per square foot of new construction and that the price includes an upfront not-to-exceed development fee instead billing staff time against the project as an activity delivery fee.

A motion was made by Frasher, seconded by Ald. Coe, to recommend approval of the request. The motion PASSED by a Voice Vote.
