Members of the Public Safety and Licensing Committee,

I am Akil Ajmeri, the owner and operator of three different Ayra's, two located in the Village of Caledonia and the other located in the City of Kenosha. I also own and operate Deli Food Express in Caledonia, the BP gas & convenient store on 3 Mile Rd in the City of Racine, and Subway on Hwy 32 in Oak Creek. I respectfully request the committee grant a Class A license to Ayra's Cigar & Convenient Store located at Reefpoint Marina. I recently signed a 5- year lease to operate the convenient store at Reefpoint Marina.

The store I'm operating at Reefpoint will be a high-end cigar & convenient store, featuring a walk-in humidor, primarily serving boaters in the Racine area. I'm investing a significant amount of money to remodel and improve the store. In addition to cigars, I plan to offer boat supplies, groceries, toiletries, coffee, ice cream, and sandwiches. Beer and alcohol would compliment the store and serve the boaters visiting the Racine area extremely well. It is important to note that none of my stores have ever been found in violation of the license.

It is also important to note that the store will be open only on a seasonal basis. I plan to operate it for 5 months of the year, May-Sept. I believe the liquor license is extremely important to the success of Ayra's at Reefpoint Marina. I know the downtown and the marina are an integral part of the City of Racine and want to see Ayra's become a valued location that will reflect positively on the City.
