5/19/2012 Tropical Paradise – 1446 M.L. King Dr. – Man With a Gun (Substantiated – Active Investigation): On 5/20/12, an officer met the bouncer for Tropical Paradise at the front counter of the Police Department to report incidents that occurred on 05/12/12 and 05/19/12. The bouncer explained that on the 12th a party came into the bar and pointed a firearm at several patrons. The bouncer admitted to knowing of the incident, but not calling the police. Then on the 19th, he was threatened by the same individual with the gun. When police responded to the area, he said nothing to them about the individual with the gun. This is an active investigation; and therefore, details are being withheld to ensure the integrity of the investigation. However, the fact that the bouncer did not alert police at the time, on either occasion, is a cause for great concern and the reason for the inclusion of this incident despite the ongoing investigation. 12-25008; Call received: 1337 hrs, Officer responded: 1342 hrs.

5/6/2012 Tropical Paradise – 1446 ML King Dr. – Fight (Substantiated – Warrant Recommendation Submitted): Officers responded to the intersection of Hamilton St. and Douglas Av. where they found a female subject that claimed she was assaulted by her boyfriend. The female had visible injuries to her face consistent with being punched. She stated that she and her boyfriend were inside Tropical Paradise celebrating her birthday when they began arguing and then fighting inside the bar. The fight moved out to the street and then they travelled to her grandmother's house. A short while later she called police. A witness was interviewed who confirmed the fact that the assault occurred inside the bar, but the witness added that the female "victim" was antagonizing the boyfriend and attempting to start a second fight with him after they left the bar. The boyfriend was never found and the officer submitted a warrant recommendation to the DA's Office. However, the DA's Office declined prosecution due to credibility issues with both the female "victim" and the witness. It should be noted that no calls for a fight were received from the bar; it was not until the female called a while later from Hamilton and Douglas that Dispatch was advised of an altercation. 12-21963; Call received: 0206 hrs, Officers dispatched: 0208 hrs.
