Subject: Petition to exceed quota for a "Class A" Fermented Malt Beverage and Intoxicating Liquor License for 930 Washington Ave. (1st District)

Mr. Curtin explained that Officer Beal has been working at Wharf 209 as an off duty officer and Wharf 209 is looking for a second off duty officer. Officer Beal primarily helps check identification to prevent any underage patrons and tries to intervene before any potential problems arise. Mr. Curtin stated he does have cameras and they record each entrance and will record up to fourteen days. The committee members asked if Mr. Curtin has a card reader, but he does not. It was recommended that he may want to invest in one.

Deputy Chief Schulz explained that the Chief of Police was in favor of placards, but it was up to the committee to decide the best solution. The committee also discussed changing the ordinance to permit overnight on street parking restrictions Downtown from 2 AM to 3 AM.

A motion was made by Alderman DeHahn to have the Attorney's Office amend the ordinance until 3 AM in the area of State Street to Seventh Street, Main Street to Villa Street, seconded by Alderman Coe.
