Wednesday, January 1, 2025

PUB ON WISCONSIN - 525 Wisconsin Ave - *civil trouble* called in by named caller - 5 to 6 people arguing and in some sort of scuffle. All parties were dispersed when officers arrived on scene. call received 0142 - call dispatched 0144 - on scene 0148. **25-000047**

THE BRICKHOUSE - 316 Main St - Fight called in by Douglas (owner) - several females fighting and were escorted out of the bar by security. Officers unable to relocate the problem parties. Call received 0300 - Call dispatched - 0302 - Officers on scene - 0308. **25-000062**

HONORS RACINE - 1330 Washington Ave - Civil trouble, called in by unknown caller - disgruntle customer trying to fight other customers. Problem party left establishment prior to officers arrival. Call received 0325 - Call dispatched 0325 - Officers on scene 0327. **25-000063**

PUB ON WISCONSIN - FIGHT, called in by bartender - customer fighting with another customer and refusing to leave. Problem party was finally escorted out of the building when another fight of 10 people started inside the bar as officers arrived on scene. Due to the nature of the fight, OC spray was deployed to gain control of the situation. As people were leaving out of the building, several males rushed back into the bar starting another fight involving six people. Officers deployed OC a second time to gain control. Three parties were arrested and taken to RCJ, while two parties were written citations. Call received 0443 - Call Dispatched 0445 - Officers arrived on scene 0446. **25-000068**

MY WIFES BAR MY GRILL - Welfare check, called in by a named caller - Caller stated he received messages from a female party who was at this establishment and claimed she needed help possible mental help. Upon officers arrival, her welfare was checked and this party stated she was not suicidal. This party also had a warrant for her arrest and was taken into custody without further incident. KAYLAS BAR - 2054 Lathrop Ave - Fight, called in named caller (bartender) - Dispatched received a call for approx. 6 -7 females fighting. Upon officers arrival, there were no active fights, and non of the patrons wanted to speak with police. All non-employees were asked to leave the establishment while police were on scene.
