Mayor Friedel and Chief Wahlen explained the purpose of this grant to committee members. Mayor Friedel stated that this was the first of the stimulus and the grant application has already been submitted to meet the required deadline. Mayor Friedel explained this would be a four year grant with the City funding the 4th year at about \$250,000.00. He proposed that each year 1/4 be levied each year with the fourth year only 1/4 would need to be picked up and it would not be a burden on taxpayers. Chief Wahlen stated the grants would be used in three parts(beat officer, walking/riding and possibly another COP House).

Alderman Mozol voted "no" to moving the item forward and approving the request.
