On a motion by Hart, seconded by DeHahn, the Committee approved the minutes as printed.

Subject: Communication from the Sales/Marketing Director of the Racine County Convention and Visitors Bureau requesting permission to use city right-of-way on Thursday, July 24, 2008, for the 2008 International Cycling Classic.

Recommendation: The Racine County Convention and Visitors Bureau be granted permission to close the following streets to hold the 2008 International Cycling Classic to be held on Thursday, July 24, 2008, from 8:00 a.m. to 9:00 p.m.,

Main Street from State Street to Sixth Street, Sixth Street from Main Street to College Avenue, College Avenue from Sixth Street to Water Street, Water Street from College Avenue to Fourth Street, Wisconsin Avenue from 4th Street to State Street, State Street from Wisconsin Avenue to Main Street;

with the following stipulations:

A. A hold harmless agreement be executed.

B. A liability insurance certificate be filed prior to this event.

- C. Any overtime costs incurred by any City department be charged to the sponsor.
- D. The sponsor shall notify all abutting property owners seventy-two (72) hours in advance of this event.
- E. The sponsor shall pay a \$800.00 special event fee.
- F. Sponsor shall be responsible for placement of all traffic control devices.

Dave Blank appeared and noted this is the first time in 11 years the International Cycling Classic has been held in Racine. The race should be completed about 8:00 p.m. Rick noted the condition of 6th Street is temporary pavement and Wisconsin Avenue has some joint deterioration and wasn't sure if that is an issue. Dave and the representative from the ICC noted this route works and is good for the businesses and community downtown. John noted the group would have to apply for the street closing and get a signed detour route and traffic control at their cost.

Subject: Communication from the developer of Woodland Pointe, Lincoln Lutheran requesting that the proposed sanitary sewer and water main that will serve the 14-unit condo development be public utilities, owned and maintained by the City.

Recommendation: That the Mayor and City Clerk be authorized and directed to enter into a development agreement with the developer of the Woodland Pointe Condominium project. Terms of the development agreement will include:

- A. The construction of storm and sanitary sewers to City specifications which will be considered services and which will be the responsibility of the private property owners to maintain in the future.
- B. The construction of water mains in accordance with the requirements of the Racine Water Utility within easements satisfactory to perform future maintenance activities. These water mains will be owned by the Racine Water Utility.
- C. The paving of Kasper Street from the south project limits to Carlton Drive with portland cement concrete pavement. The cost to be paid fully by the developer.

Fiscal Note: The assessment to the existing property owners along Kasper Street will be waived due to this agreement.

City of Racine

Rick explained the condominium project and the connections to the City's sanitary, storm and watermain systems. The Racine Water Utility needs inspections and easements in order to take ownership of the watermain. The City of Racine would simply grant permission for the storm and sanitary as laterals to private property. Rick noted Casper Drive would be built in concrete at the developers expense and no cost to the abutting property owners. Brian O'Connell described the condo development and noted the developer agreement needs to be approved.

On a motion by Hart, seconded by DeHahn, the Committee approved the request.

Leneen Schrieffer appeared and requested the alley be rebuilt. It is in a difficult condition to maintain and has been difficult to plow on a frequent basis and asked the Committee to consider rebuilding the alley. Rick noted the process and it needed to be submitted as a preliminary resolution.

On a motion by Hart, seconded by Weidner, the Committee approved a preliminary resolution.

Rick Heller appeared and noted the are approximately 18,400 rental units in the City. That is approximately 50% of the residential housing stock. Based on these figures, a three-year cycle for rental inspections would take 3 full time employees. Rick cited examples in Beloit and Waukegan and discussed options on rental license fees or inspection fees to fund the program. Alderman Weidner suggested an Ad-Hoc Committee to determine how this inspection process would work. Rick Jones suggested the Chief Building Inspector bring back to the Committee in 30 days, examples of how other communities perform this function.

On a motion by Hart, seconded by Weidner, the Committee deferred the item.
