Subject: Change Order No. 1 on Contract W-13-4, 2013 Pavement Replacement, RAZA of Racine, LLC (Contractor)

Recommendation: Approve

The General Manager submitted Change Order No. 1 on Contract W-13-4 in the amount of \$33,794.50, bringing the total contract amount to \$264,217.00 and recommended approval.

The General Manager stated that since no information was obtained regarding this request, he recommended that this item be deferred.

Subject: Policy Decision on Raising Employee Share of Medical Expense Premium from 7.5% to 10%

Recommendation: Approve to keep employee share of medical expense premium at 7.5% with the option of participating in a 5% premium plan with a higher out-of-pocket expense

The General Manager noted that the Finance Committee of the Board of Waterworks Commission recommended that the health care premium for Water Utility employees stay at 7.5% for employee share for employees currently paying 7.5%. Also, all employees would be able to participate in a 5% premium plan with a higher out-of-pocket expense, which the City is offering. Furthermore, employees would have to pay their own premium if they chose the option of having dental care. For recent hires paying a 10% premium, the Utility will pay for single dental coverage.

A motion was made by Mayor John Dickert, seconded by Ralph Schwarz, that this be Approved. The motion PASSED by a Voice Vote.

12. <u>14-10580</u>

Subject: Proposed Policy Regarding REC Fees for Large Developments

Recommendation: Defer

The General Manager gave an explanation of a large customer REC fee payment deferral policy that was drafted by Attorney Joseph Muratore based upon a report prepared by Ruekert-Mielke. He noted that the Utility previously met with the City of Racine, and the Villages of Mt. Pleasant and Sturtevant regarding REC fees, and that the report was sent to each of them. After further discussion, it was decided that this item should be referred to the Finance Committee of the Board of Waterworks Commissioners for further discussion and review.

A motion was made by Mayor John Dickert, seconded by James Spangenberg, that this be Deferred. The motion PASSED by a Voice Vote.

Subject: Proposed Policy to Implement ACT 274

Recommendation: Approve

The General Manager explained a proposed policy on tenant/landlord invoices as a result of ACT 274. He noted that ACT 274 will go into effect in 2015. As a result, the General Manager requested authorization to utilize a Tenant/Landlord application and registration form in the Water/Wastewater Administrative Office for their customers.
