## Approval of Minutes for the January 30, 2006 meeting.

A motion was made by Vice Chair Shakoor, II that this file be to Approve the Minutes .

ORDINANCE NO. 01-06 to amend Sec. 30-84(c) of the Municipal Code of the City of Racine, Wisconsin relating to Garden court crypts construction and maintenance fund.

Mayor Becker appeared explaining how the fund started out.

Alderman Maack said that Mrs. Drummond sent in a letter stating concerns how other departments are spending the money in the fund account.

*Mrs.* Sharon Baldukas, president of the Cemetery Board, appeared stating her concerns about funds spent from this fund. She believes procedures need to be followed and also stated the other board members had concerns. She had no objections of the insertion at the end of the first sentence in the ordinance.

Alderman Maack explained that there needed to be a check and balance system in place and suggested that the Cemetery Commission make a presentation to the Committee of the Whole to explain the role of the cemetery commission and the cemetery fund.

Alderman Weidner stated she wasn't opposed to the language in the ordinance and also believes in a check and balance system.

Investigator Diener gave a synopsis of the incident, stating on January 1, 2006, officers responded to a call of shots fired. When they were in the area, numerous volleys of shots were heard, coming from 1801 Mead Street. The building was secured, SWAT was activated, responded, and cleared the building around 4 AM. Five people were detained.

Three rifles and three handguns were seized. One of the handguns was located in the store, on a shelf under the cash register.

Three hundred three (303) casings were recovered. The shots were directed in the air; however, the adjacent homes were occupied. One gun was reported stolen in Des Moines, Iowa. Thomas Marshall III, admitted bringing the ammunition to the house.

Alderman Cherri Cape appeared stating her concerns regarding this grocery store. She had numerous calls about this store from the neighbors that evening and also had concerns about the number of weapons seized. She stated she had spoken with the Police Department regarding this incident. She said that some of the other individuals charged in this incident also worked at the store. Thomas Marshall, (1015 Eighteenth Street) owner of T's Corner Grocery Store appeared. He apologized and said he didn't realize he couldn't shoot weapons in the air. He also said he was Thomas Marshall Jr., not Sr. and stated the incident didn't happen at the store but in an adjoining building. He felt that ever since he started the business he hasn't been treated fairly.

Alderman Shakoor stated he was highly upset and this type of incident would not be tolerated.

Alderman Helding stated he was very concerned and this was not acceptable.

The aldermen voiced concerns with the history report for this business and discussed a possible due process hearing.

Attorney Wright explained the committee needs to know the status of the charges before they pursue a due process hearing.

A motion was made by Vice Chair Shakoor, II that this file be Recommended For Termination .

He wants this to be a one-stop shopping family grocery store. Alderman Keith Fair appeared and stated the owners had done a lot of improvements and to be competitive, they should be allowed to sell beer.

Alderman Shakoor and Alderman Weidner voiced concerns that another business selling alcohol was not good for the neighborhood because of the high concentration of establishments that sold alcohol in the area. They would like more time to study this application.

ORDINANCE NO. 2-06 RELATING TO OFFENSES - GANG LOITERING

George Meyers - 1307 Wisconsin Avenue - appeared voicing disapproval of this ordinance. He believes there needs to be good relationships between the police and the citizens and feels the adoption of this ordinance will hinder that.

Alderman Shakoor stated he believes we should give the Chief of Police all the tools he needs to combat problems in Racine. He also believes citizens have the responsibility to come forward and give the police information.

# ORDINANCE NO. 3-06 RELATING TO PUBIC PASSENGER VEHICLES; TAXICABS.

Attorney Wright said the City is in negotiations with Mr. Hafiz to acquire the City's Taxi Cab service. The ordinance states exclusive rights to one owner for a period of four years and the owner can have up to 12 taxis. Current zoning restricts Mr. Hafiz from putting a storage container at his gas station or allowing him to maintain the taxis there. Attorney Wright also explained that anyone could bid on taking over the City Taxi Cab service. Whomever got the bid, would be given exclusive rights for the four year period.

John McAuliffe, director of the Safe Ride Program, wanted to know if the new taxi service would honor the current Safe Ride Program. Attorney Wright explained that was a business decision between him and Mr. Hafiz.

Alderman Fair voiced concerns regarding the City giving someone exclusive rights to the taxi service.

A motion was made by Vice Chair Shakoor, II that this file be Recommended For Approval .
