I do not have the financial, nor the time, resources necessary to continue to maintain the lots on Eleventh Street. I have attempted to sell the lots, but my realtor has informed me that the lots are "unbuildable" and therefore unsellable. I understand that the lots would be buildable with the construction of a retaining wall. Again, however, I haven't the resources to invest in that construction.

The City of Racine could more likely invest the time and effort necessary to put the lots to good use. So, I would like to donate the lots to the City. By donating this land I will relinquish all rights, all responsibilities, and all financial obligations associated with this land.

If the City Council accepts this offer, I understand that I would be required to sign over ownership to the City in more formal documents. I would be happy to sign whatever documentation the City develops to accomplish the change in ownership and to hold me free from any current or future obligation in association with this land.
