RE: Amendment No. 1 for Underground Facility Locating Service Agreement –  
Precise Underground Marking Corporation, Contractor

We have received an amendment from Precise Underground Marking Corporation, Milwaukee, WI, to mark underground street lighting and traffic signal infrastructure. The amendment is for an extension of the existing contract with a per ticket price of:

- Prescreens - \$9.27;
- Locates - \$11.85
- Site Visit/No Conflict - \$11.85;
- Emergency During Business Hours (Clear/No Conflict/Site Visit/Locate) - \$11.85
- Emergency After Business Hours (Clear/No Conflict/Site Visit/Locate) - \$41.20
- Projects - \$25.75 per hour

This extension is from January 1, 2012 through December 31, 2012 and represents no change from the 2011 rates.

Funding is available in the 2012 operating budget in Account No. 101.590.5610, Street Lighting – Professional Services.

If the Committee agrees, they should move to approve the amendment and authorize the Mayor and City Clerk to enter into the agreement.
