Chairman Shakoor read them a little bit or ordinance 41-06 detailing where they are responsible for controlling their parking lot and continuous training of their bartenders, bouncers and other staff members.

Ms. Burbee requested a copy of the incidents summary report from the police department as well as a copy of ordinance 41-06. It was arranged for her to pick up the information from the City Clerk's office. After they review the incidents an ordinance, they should report back to the committee in two weeks as to what measures they will be taking to correct the on-going problems.
