REPORT FOR THE MONTH OF December 2006

Highlights:

- <u>Clinical Chemistry</u>: Shahla ran cholesterol panels on 98 employees of A & E Hand Tools which we drawn by Michele Breheim as part of Debbie Herz-Mazius worksite wellness promotion program. Julie and Shahla were fit-tested and given new respirators.
- <u>Microbiology</u>: The laboratory was inspected the WI Department of Agriculture, Trade and Consumer Protection for our water and dairy testing programs. The inspection went well with the laboratory receiving only a minor deficiency with regard to our pH meter.
- <u>Blood Lead</u>: Sixty-eight patient samples were screened for lead poisoning in December. There were no elevated blood lead results reported.
