#### **6. 07-1510**

**Subject:** Direct Referral - Communication from the General Manager of the Wastewater Utility wishing to discuss the Financial Assistance Agreement for Clean Water Fund Program, Project No. 4285-14, Basin Z Wastewater Storage Facility

**Recommendation of the Finance and Personnel Committee on 12-10-07:** The Mayor and City Clerk be authorized to enter into a Financial Assistance agreement with the Wisconsin Department of Administration for a Clean Water Fund Loan in the amount of \$3,481,931.

**Fiscal Note**: No City funds are involved with the Clean Water Fund Loan from the State of Wisconsin Department of Administration. The loan rate will be 2.475%. The loan will be repaid with Wastewater Utility funds.

Recommendation of the Wastewater Commission on 12/18/07: The Mayor and City Clerk be authorized to enter into a Financial Assistance Agreement with the Wisconsin Department of Administration for a Clean Water Fund Loan for the purpose of funding the Basin Z Wastewater Storage Facility project in the amount of \$3,481,931. Further recommends that \$3,481,931.00 in Wastewater Revenue Bonds be issued to the State of Wisconsin Clean Water Fund Program in exchange for a Clean Water Fund Loan in the same amount.

Fiscal Note: Funding will be provided by the Wastewater Utility.

The General Manager stated that the Finance and Personnel Committee approved authorization for the Mayor and City Clerk to enter into a Financial Assistance Agreement with the Wisconsin Department of Administration for a Clean Water Fund Loan for the purpose of funding the Basin Z project.

A) The General Manager stated that he signed an agreement with Quarles & Brady for a fee of \$7,000.00 for the purpose of preparing a bond issue with regard to the Clean Water Fund Loan.

- B) The General Manager noted that he met with the Milwaukee Metropolitan Sewerage District, Green Bay Wastewater Utility, and Madison Metropolitan Sanitary District to discuss their procedures in handling personnel issues. He stated that he is currently working on reviewing the Utility's performance evaluation forms. He also mentioned that he has corresponded with a firm by the name of Carlson Dettmann to help with such issues.
- C) The General Manager mentioned that the Utility is looking to purchase a portion of land located by the building formerly known as the Case Foundry which is currently owned by Case New Holland.

There being no further business, Commissioner Hewitt made a motion, seconded by Commissioner Pellegrom, to adjourn the meeting at 4:55 p.m. The motion passed unanimously.
