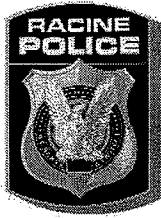

03-04-10 15:20 hrs. Chucky Cheese – 5612 Durand Ave. – Restaurant manager male 41 y.o. informed officers of a male customer assaulting a female during a domestic trouble in the building corridor. Suspect and victim left PTA. No complaints filed. 10-011256
