Wednesday, April 15, 2026

Honors Racine - 1330 Washington Ave - Officers were dispatched in reference to a fight. Arrest were made in reference to the incident. It was also learned, one of the parties involved was 18 years of age and was drinking inside Honors. A citation was also issued for underage consumption of alcohol. **26-018306**

Thursday, April 16, 2026
