Re: Damage to garage door at 1219 Blaine Avenue

To Whom It May Concern:

We are asking your permission to allow the garage at 1219 Blaine Avenue to remain in its current location. This garage was added to the house during the 1970's by the previous owner. The garage door is positioned 37" from the alleyway compared to 86" for the neighboring garage.

A city snowplow backed into the garage door in mid-January 2009 which resulted in having to replace the door at a cost of \$997. A copy of the police report summary and invoice from Jim's garage door is included.

The City Attorney's office has asked us to seek permission for the alleyway encroachment before proceeding with settlement.

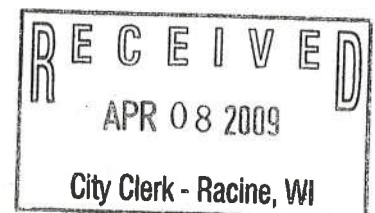
