promissory note, land use restriction agreement, and HOME

Fiscal Note: This item increases the total amount of HOME funds loaned to the St. Paul Commons project to an amount not to exceed \$300,000 total. There are sufficient HOME funds available to meet this request. All principal and interest would be returned to the City as HOME program income.
