Attorney Jeremy Chavez appeared on behalf of the applicant. He informed committee members that he had been in contact with former Attorney Weber in regards to video camera and security issues that were raised by committee members. He informed the committee that he had now spoken with Deputy Attorney Nicole Larsen and stated that his clients were not able to financially obtain security guards but they do have eight security cameras. Deputy Attorney Larsen spoke about two concerns she had, updating the committee that patrons were in the bar on three separate occasions, also it was the committee's decision to determine if the establishment was operating as a restaurant or tavern. There was much discussion over what the issues were that night. However, Attorney Larsen's position was (and is) that the committee's decision was to renew or not renew the "Class B" license. The licensee had raised the issue that it was a restaurant: but I did not feel that the renewal process was the appropriate time to discuss that matter. The only matter before the committee was the renewal. There was brief discussion among committee members, police department, Deputy Attorney Larsen and Attorney Chavez in regards to the above issues. Motion was made by Alderman Dehahn and seconded by Alderman Coe to approve contingent on the window not being open after bar time. Motion was tied by the following vote:
