A previous committee set up under City Development was referenced by both the speakers and committee members and it was suggested we find the notes for Citizens for a Racine Sustainable Listening Committee from the fall of 2008.

It was noted by Mr. Bybee that recent changes in the State Legislature with SP466 and Act 107 and Act 108 have made changes in the landlord/tenant relationship. He felt most landlords would be glad to work with Police in trying to solve nuisance situations.

Chairman Wisneski would like the following points noted for the potential ordinance #1 That at least one of the three previous visits to the property included an event which resulted in an action greater than a warning.

#2 Should PSL be the appropriate committee to address this.

#3 This should not be an ordinance that domestic or child welfare issues rise to the level of a nuisance property.

#4 Any letters or warning should be based on business days, not actual days.

A question arose from Juley Kennedy whether the existing Phoenix System can be adapted to be used by the property owners to follow up on calls to their property. This was stated as possible during previous discussions.

Chairman Wisneski thanked Attorney Weber and the staff from the attorney's office for the copies of ordinances from other municipalities for reference.
