Micah Tharpe appeared before the committee to speak on behalf of the license. He is taking over for Lavonda Perkins, who is leaving the business. He has 12 years of

experience running events in Milwaukee, where he is a Mason. He plans to have an off-duty officer at the bar to help manage the crowd at closing time. He plans to keep the surrounding sidewalk and street clean by not selling glass half pints, as broken glass from these items was previously a problem at this location. He plans to have the off duty officer(s) monitor patrons who might attempt to park in the Nash's parking lot, which was previously an issue. RPD stated that Wisconsin DOR inspected the premises and located tobacco-based hookah that was not purchased from a licensed distributor. He stated he has since stopped purchasing tobacco-based hookah. The City Attorney's Office stated that information was provided to them that Mr. Tharpe has been operating as 509 Social Lounge since August 1, 2018, without a FEIN or seller's permit by using that of the prior owner/agent. He stated he believed it was under 509, not King Daddies. He stated he had a scheduled meeting with the Health Department the following morning. He stated because he does not own the building, he cannot speak for the owner's intentions regarding improving its appearance. He intends to pick up garbage to keep the premises as clean as possible. Capacity limit is 80 persons. They intend to serve bar food: fries, frozen pizza, and chicken, among other things. Hours of operation will be daily 5:00 p.m. until 2:00 a.m., but during Sunday football season from 12:00 p.m. until 1:30 a.m.
