Ord.0001-17 Ordinance 01-17 - Traffic Violation Fine Schedule

An ordinance to amend Sec. 94-17. -Traffic violation fine schedule in Chapter 94 Traffic and Vehicles, of the Municipal Code of the City of Racine, Wisconsin.

The Common Council of the City of Racine, Wisconsin, do ordain was

follows:

<u>Part 1</u>: In subsection (b) of Sec. 94-17.-Traffic violation fine schedule, remove the line for Sec. 94-143 that says "Effective 1-1-2008 \$11.00."

<u>Part</u> 2: In subsection (b) of Sec. 94-17.-Traffic violation fine schedule, amend the dollar amount for 94-145 Parking limited from "\$15.50" to "\$20.00."

<u>Part 3</u>: In subsection (b) of Sec. 94-17.-Traffic violation fine schedule, remove the line for Sec. 94-145 that says "Effective 1-1-2008 \$15.50."

<u>Part 4</u>: This ordinance shall take effect upon passage by a majority vote of the members-elect of the City Common Council and publication or posting as required by law.
