9. <u>10-5917</u> **Subject:** Retirement Announcement of Chief Engineer, Chuck Schweitzer

Recommendation: Accept Resignation

The General Manager noted that he received a letter from the Chief Engineer, Chuck Schweitzer, giving his notice of resignation. He said that his last day of employment with the Utility will be January 7, 2011.

A motion was made by John Dickert, seconded by Ronald D. Hart, to accept Chuck Schweitzer's resignation. The motion PASSED by a Voice Vote.

10. 10-5918

Subject: Consideration of a Report Entitled "Review of Positions and Grades for the Racine Water Utility"

Recommendation: Approve

The General Manager noted that since the Chief Engineer has resigned, the Utility decided to downgrade the range for this position based upon a review of similar positions in Southeast Wisconsin, and promote Chad Regalia to the position of Chief Engineer as a result of a restructuring plan for the Racine Water Utility. He stated, in turn, that Chad Regalia's old position of Civil Engineer II would not be filled. The Commission reviewed recommendations for this position, as well as others in the Racine Water Utility, as part of a restructuring of engineering and a review of current duties and responsibilities for other staff as well. The motion is to authorize the General Manager to implement the recommendations as discussed in the restructuring plan and to make changes to job descriptions as necessary to reflect current and future duties necessary and to provide proper compensation as a result of those duty changes as presented to the Commission. The restructuring will reduce staff by one position and save approximately \$110,000.00 in the 2011 budget.

A motion was made by John Dickert, seconded by Ronald D. Hart, that this be Approved. The motion PASSED by a Voice Vote.

11. Adjournment

There being no further business, Alderman Ronald Hart made a motion, seconded by Mayor John Dickert, to adjourn the meeting at 4:58 p.m. The motion passed unanimously.
