The Transit and Parking System Manager distributed a memo with all amounts compared to last year and other peer transit agencies. The Fed/State percentage share is down 0.5%. Racine collects more farebox revenue than any other "Tier B" transit agency. (Tier B comprises the 24 largest transit agencies after Milwaukee and Madison.) Memo is in the Commission files.

General Manager's Operations Report

Comparing 2018 to 2017 for March fixed route ridership was down 4.4%, revenue up 8.4%. Paratransit was up 5.2%, revenue down 8.5%.

Comparing 2018 to 2017 for April fixed route ridership was up 1.3%, revenue up 8.4%. Paratransit was up 24.4%, revenue up 27.3%.

Comparing 2018 to 2017 for the 1st Quarter, fixed route ridership was down 5.3%, revenue down 4.9%. Paratransit was up 9.4%, revenue up 3.7%.

Overtime will come down with the addition of three new drivers.

Motion made by Balkcom, seconded by Kowbel to receive and file. Passed unanimously.

Transit and Parking System Manager's Report

RYDE received a \$360,000 grant to pay for 80% of a full size bus. We were one of seven Tier B transit agencies that received funding for a vehicle; one agency got two vehicles. The balance of the 24 Tier B agencies received no capital grant. Funds are administered through our ongoing Federal agreement.

Service changes went into effect on April 30, 2018. Service by request-only on Route #27 to Goodwill on International Dr. is popular. Route #20 now also serves Goodwill. Both Goodwill and Mt. Pleasant were pleased.

The June Commission meeting will cover several parking issues.

Motion made by Heckenlively, seconded by Kowbel to receive and file. Passed unanimously.
