It is currently unclear if Local 2807 is in good standing with AFSCME, if they will recertify as a Union as recognized under ACT 10, or whether they will officially decertify as a Union body under the governing rules in the state of Wisconsin. The General Manager will try to determine what the current status of the hourly employees at Racine Wastewater is at this time. Based on those findings, the General Manager will either negotiate, bargain, or simply offer the hourly employees a wage increase in accordance with the recommendations of the Wastewater Finance Committee at the Special Meeting of the Wastewater Commission Finance Committee dated March 20, 2014 and such minutes as approved by the Wastewater Commission.
